Few studies in financial economics have had the ground-breaking influence of "The Pricing of Options and Corporate Liabilities" by Fischer Black and Myron Scholes and "The Theory of Rational Option Pricing" by Robert C. Merton. Published in 1973, a time when options were specialized and economically insignificant securities, these works underlie almost every facet of the theory and practice of modern-day finance, including sparking the growth of the derivatives industry whose notional value exceeds \$600 trillion. By bringing together leading academics and practitioners, the Conference on Financial Innovation: 35 Years of Black/Scholes and Merton celebrated their foundational work, providing an open forum for discussion of new ideas about derivatives contracts and contract markets.
